In partnership with Nashville Public Television, the League will host a **Community Engagement Initiative "Next Door Neighbors."** We will convene one or two small group sessions of interested League members to discuss Nashville's response to its changing demographic based on the influx of immigrants and refugees. Open Meetings and Open Records

Issues related to open government have been on the front page for several months. Three different bills have been proposed. The first, SB 3275 McNally, HB 3636 McDaniel, includes the study committee's recommendations; creates the office of ombudsperson; makes changes in the Open Meetings Law, including a provision that would weaken it by allowing up to three officials of a body to meet privately to discuss public business; and generally strengthens the Open Records Law.

The second bill, SB 3280 McNally, HB 3637 Mc Daniel—and preferred by McNally—omits some of the weakening provisions in SB 3275 but adds several other exemptions including allowing private meetings when school boards are evaluating the school director's performance and when city councils or county commissions are discussing the sale or purchase of property. The League's position on the first two bills is to support the positive open record changes but to oppose the negative open meetings changes.

The third bill, SB 3593 Burchett, HB 3945 Lynn, makes some needed improvements to the existing Open Meetings Act; includes more controls (no votes allowed) on what can happen inside executive sessions that are currently allowed by law; and requires that minutes be kept and made public without the information the executive session is designed to protect. It also includes the Open Records improvements. This bill was drafted by the Tennessee Council on Open Government headed by Frank Gibson and requested by Knox County citizens. Marian Ott is the League's representative on this group. The League supports this bill.

TCOG and representatives of cities, counties, and school boards have agreed not to pursue changes this year in the open meetings law but to continue talking beyond this legislative session. Sen. McNally is expected to present only SB 3280 with public records improvements and the ombudsperson but minus any changes to the sunshine (open meetings) law. TCOG feared that proceeding this year could result in weakening current law.
